Gentlemen: -

For the past four years I have been reading a great deal about the developments of television, and have followed with interest, the developments that have been made during these four years. Being interested in the work in radio and television, I have followed the art with interest to the present date.

About three months ago we formed a Corporation in this territory which is organized under the laws of the State of Louisians, known as the Southern Television and Broadcasting Company, Inc. It is the purpose and intention of this Corporation to carry on an extensive research compaign in the art of television in the Southern territory.

We purchased several receivers from the Western Television Corporation for testing purposes and experimental work, and have been operating on the amateur phone band, on 160 meters. We have shown some very remarkable progress in our experiments in the art of television transmission, and have been able to show perfect television pictures at a distance of 100 miles from our transmitter, this being as far as we have had the opportunity to test our range. I am sure that we are in the television business at the right time and expect to advance with the art.

We thought perhaps your Company would be interested in knowing that such an organization has been started in the Southern territory, as I am sure that we will be able to give your Company quite a bit of busikess in the near future, both in transmitting and receiving apparatus. It is our intention to install larger, more elaborate transmitting apparatus, just as soon as we can obtain the necessary license from the Commission. We expect to install and operate experimental television stations in practically every major Southern City, and maintain a retail television cales Department in these Cities.

I mu mure that you can readily see that we will shortly be in a position to give your firm a great deal of busikess, if you can supply our demands at prices that will be suitable, and we would greatly appreciate hearing from you at your carliest convenience regarding your Company's ability to serve us.

Gentlemen:-

I suppose you think that I am never going to pay you for the Baird television receiver which you shipped to me a long time ago, but things have been moving slow for me and I have just now gotten started in the television business in the right way.

I have recently associated myself with a group of business men who believe in the future of television and we have formed a Corporation, under the laws of the State of Louisiana. This Company is capitolized at \$50,000.00. We have purchased the necessary television transmitting equipment to transmit television, using the 45-line system, as manufactured by the Western Television Corporation, Chicago, Ill. I am at present using my amateur station of one hundred watts, and am now showing perfect pictures for a radius of one hundred miles, this being as far as we have had the opportunity of testing our range.

I have accepted a position with this Company, and have agreed to work with them for a short time, until we can make the necessary connections to obtain a regular license from the Commission, and can make the necessary arrangements with television radio receiver manufacturers, to distribute their products in this territory. We have organized a good sales force, and are now ready to go after business in a big way. My selary with this Company will not start for another thirty days, however, and I will see that you are paid for the machine that I now have, out of my first check.

The Echophone Company allows the Company a discount of 50-10-2, and the Company pays cash for all merchandise, which I am sure would interest you.

May I say that I greatly appreciate your courtesies to me in the past, and I am sorry the receiver that I now have is not a 45-line system, as I could sell it immediately, and just as soon as I can, I am going to have it changed and sell it.

If I can be of any assistance to your Company in this territory, all you have todo is call on me.
